







Background Information


AAFP Credit System

- Directly certifies CME activities for AAFP Prescribed or Elective Credit
- Performance Improvement (PI) CME activities are one of six activity types offered

ABFM

- Certifies family physicians
- Assists Diplomates in maintaining professional standards
- Participation in Performance Improvement (PI) is one of the certification requirements

What is a Performance Improvement (PI)?



- Structured activity utilizing specific performance metrics
- Assess current practice
- Implement change in practice
- Re-evaluate performance


