



## FLORIDA FACT SHEET

### AAFP on Health Reform

The AAFP believes that policies should be adopted to ensure continued progress towards health care for all supported by a payment system that rewards value of care over volume of service. The health system should promote prevention and wellness, protect patients from financial barriers to needed services and build a primary care physician workforce that can meet the growing demand for care.

### Florida Family Medicine

- There are 4,979 family physicians in Florida.
- Florida has 16 family medicine residency programs.
- Florida has 127 medically underserved areas/populations.
- 3.5% of the residents in Florida live in a health professional shortage area.

### Medicaid in Florida

- In 2015, 18% of people in Florida were covered by Medicaid/CHIP.
- Medicaid/CHIP enrollment increased by 1.2 million between 2013 and 2016.
- Florida's uninsured rate decreased from 19% in 2013 to 13% in 2015.
- In Florida, 39% of Medicaid spending is for Medicare beneficiaries.<sup>1</sup>

### Impact of the Better Care Reconciliation Act (HR 1628 being considered by the US Senate)

- 2,086,500 people in the state of Florida would lose their health coverage by 2026.<sup>2</sup>
- In Florida, 3,116,000 non-elderly adults have a declinable preexisting condition.<sup>3</sup>
- In Florida, premiums would rise. For example, if a 40-year-old in Tallahassee, earning \$30,000 a year, purchased a silver plan they would pay a \$580 increase in premium. A 60-year-old would pay a \$3,710 increase in premium.<sup>4</sup>
- The BCRA would limit access to substance abuse treatment by cutting Medicaid. In Florida, 3,228 people died of overdose deaths in 2015.<sup>5</sup>
