



## IDAHO FACT SHEET

### AAFP on Health Reform

The AAFP believes that policies should be adopted to ensure continued progress towards health care for all supported by a payment system that rewards value of care over volume of service. The health system should promote prevention and wellness, protect patients from financial barriers to needed services and build a primary care physician workforce that can meet the growing demand for care.

### Idaho Family Medicine

- There are 664 family physicians in Idaho.
- Idaho has 5 family medicine residency programs.
- Idaho has 47 medically underserved areas/populations.
- 16.9% of the residents in Idaho live in a health professional shortage area.

### Medicaid in Idaho

- In 2015, 18% of people in Idaho were covered by Medicaid/CHIP.
- Medicaid/CHIP enrollment increased by 60,100 between 2013 and 2016.
- Idaho's uninsured rate decreased from 15% in 2013 to 11% in 2015.
- In Idaho, 31% of Medicaid spending is for Medicare beneficiaries.<sup>1</sup>

### Impact of the Better Care Reconciliation Act (HR 1628 being considered by the US Senate)

- 144,700 people in the state of Idaho would lose their health coverage by 2026.<sup>2</sup>
- In Idaho, 238,000 non-elderly adults have a declinable preexisting condition.<sup>3</sup>
- In Idaho, premiums would rise. For example, if a 40-year-old in Boise, earning \$30,000 a year, purchased a silver plan they would pay a \$400 increase in premium. A 60-year-old would pay a \$3,210 increase in premium.<sup>4</sup>
- The BCRA would limit access to substance abuse treatment by cutting Medicaid. In Idaho, 218 people died of overdose deaths in 2015.<sup>5</sup>
