



MONTANA FACT SHEET

AAFP on Health Reform

The AAFP believes that policies should be adopted to ensure continued progress towards health care for all supported by a payment system that rewards value of care over volume of service. The health system should promote prevention and wellness, protect patients from financial barriers to needed services and build a primary care physician workforce that can meet the growing demand for care.

Montana Family Medicine

- There are 499 family physicians in Montana.
- Montana has 2 family medicine residency programs.
- Montana has 55 medically underserved areas/populations.
- 17.7% of the residents in Montana live in a health professional shortage area.

Medicaid in Montana

- In 2015, 16% of people in Montana were covered by Medicaid/CHIP.
- Medicaid/CHIP enrollment increased by 92,100 between 2013 and 2016.
- Montana's uninsured rate decreased from 16% in 2013 to 10% in 2015.
- In Montana, 41% of Medicaid spending is for Medicare beneficiaries.¹
- If Montana were to maintain Medicaid expansion with decreased federal support, it would increase state costs by \$24.4 million in 2021, and \$149.6 million in 2024.²

Impact of the Better Care Reconciliation Act (HR 1628 being considered by the US Senate)

- 81,100 people in the state of Montana would lose their health coverage by 2026.³
- In Montana, 152,000 non-elderly adults have a declinable preexisting condition.⁴
- In Montana, premiums would rise. For example, if a 40-year-old in Helena, earning \$30,000 a year, purchased a silver plan they would pay a \$1,390 increase in premium. A 60-year-old would pay a \$6,030 increase in premium.⁵
- The BCRA would limit access to substance abuse treatment by cutting Medicaid. In Montana, 138 people died of overdose deaths in 2015.⁶
