The programs supported by this bill are fundamental to sustaining and advancing the well-being and prosperity of our nation. The bill provided a modest overall increase for these programs, most of which have experienced significant cuts, lost purchasing power, or both over the past three years. The increased investment is essential to improve the quality of life for America's people, especially the most vulnerable among us. Our organizations are very disappointed the bill did not succeed.

As one of 277 Members in the House of Representatives that voted to support H.R. 3043 by overriding the President's veto, your leadership is deeply appreciated!
