Dear Senator/Representative,

On behalf of the undersigned 261 organizations, we write to express our strong support for swiftly enacting into law the PREEMIE Reauthorization Act (S.1562/H.R.1197)—vital legislation to reauthorize and expand research, education and intervention activities related to preterm birth—and the Preventing Maternal Deaths Reauthorization Act (PMDA) (S.2621/H.R.1909), which will strengthen federal support for Maternal Mortality Review Committees (MMRCs). Both bills passed the full House and Senate HELP Committee by near-unanimous votes during the 118th Congress.

The U.S. has one of the highest maternal mortality and morbidity rates in the developed world. Each year, more than 30,000 women experience life-threatening complications during labor and delivery, and in 2024, nearly 700 women died due to pregnancy-related causes. Additionally, the U.S. preterm birth rate has steadily increased since 2014 to 10.4% in 2024, receiving a D+ on the annual March of Dimes [Report Card](#). This increase reflects nearly 380,000 preterm births. Preterm birth also accounts for 35.8% of infant deaths in the U.S., and its annual societal economic cost, including medical care, education, and lost productivity is an estimated \$25.2 billion. Southern and Midwestern states are particularly affected by worsening preterm birth and maternal health trends.

Although there are some clinical predictors of preterm birth, all pregnant individuals are at risk for preterm birth. Infants born prematurely have increased risks of morbidity and death throughout childhood, especially during the first year of life. Long-term health impacts include intellectual and developmental delays, behavioral problems, neurological disorders, visual and hearing impairments, cerebral palsy, and respiratory insufficiency or intestinal insufficiency.¹

While many risk factors associated with preterm birth have been identified, the “biological basis for many of these risk factors and the underlying mechanisms remain poorly understood.”² The PREEMIE Act will help reduce preterm birth, prevent newborn death and disability caused by preterm birth, expand research into the causes of preterm birth, and promote the development, availability, and uses of evidence-based standards of care for pregnant women.

The PREEMIE Act supports data linkages to the Centers for Disease Control and Prevention’s (CDC) highly successful Pregnancy Risk Assessment Monitoring System (PRAMS). PRAMS collects site-specific, population-based data tracking maternal attitudes and experiences before, during, and shortly after pregnancy on 81% of births and is used by researchers and state, territorial, and local governments to plan and review programs and policies aimed at reducing health problems among mothers and infants. This legislation will also provide for a new study on the costs, impact of non-medical factors, gaps in public health programs that lead to prematurity, and calls for recommendations to prevent preterm birth.

The Preventing Maternal Deaths Act, passed in 2018, provides federal support for MMRCs. These committees are essential as we work to protect the lives and health of mothers during pregnancy, childbirth, and the postpartum period. Specifically, the bill would reauthorize,

through 2030, federal support for states to collect and analyze data on every maternal death to identify policy solutions to prevent future, preventable deaths and address disparities in maternal health outcomes. This legislation would also require the CDC to work in partnership with the Health Resources and Services Administration (HRSA) to disseminate best practices for preventing maternal mortality to hospitals, physician practices, and other healthcare providers.

Populated by representatives in public health, obstetrics and gynecology, maternal-fetal medicine, nursing, midwifery, forensic pathology, mental and behavioral health, patient advocacy groups, and community-based organizations, MMRCs are tasked with identifying maternal deaths, analyzing factors that contributed to those deaths and translating the lessons learned into policy changes. CDC currently supports MMRCs in 46 states and six territories under the Enhancing Reviews and Surveillance to Eliminate Maternal Mortality (ERASE MM) Program.

MMRCs have been instrumental in reducing maternal mortality and morbidity in the U.S. by providing detailed, unbiased reviews of pregnancy-related deaths, identifying preventable factors, and informing targeted interventions. MMRCs are a vital component to preventing many of the 87% of pregnancy-related deaths the CDC identifies as preventable.³ Continued financial support and technical assistance, data transparency, and comprehensive reviews are indispensable to preserving and enhancing their positive impact on maternal health outcomes.
