Dear Chairs Simpson and Merkley and Ranking Members Pingree and Murkowski,

We, the undersigned organizations and individuals, write in support of the inclusion of \$30 million in new funding for the Indian Health Service overall budget in the FY2024 Interior, Environment, and Related Agencies appropriations bill to address chronic clinical staff shortages by: (1) establishing Graduate Medical Education (GME) coordinators across IHS; (2) funding physician residency programs; and (3) funding clinical fellowship programs. These proven interventions to recruit, train, and retain health care workers would help reduce chronic provider shortages across Indian Country. We view these targeted interventions as part of a broader response to workforce shortages across health professions.

A new IHS clinical services funding line to establish a GME coordinating office and support four new residency programs was included in the FY2024 President's Budget Request, at \$4 million, as described on page 57 of the IHS FY2024 Congressional Budget Justification. We support the inclusion of an amount greater than \$4 million, given the large demand for GME programming in Indian Country, and the benefits that additional fellowship programs outside of GME, across cadres of health workers, would provide.

Background:

Regional physician vacancy rates were as high as 46% in 2018 (see: "The Indian Health Service and the Need for Resources to Implement Graduate Medical Education Programs" in JAMA, 2022). The physician shortages across Indian Country have been attributed to limited recruitment incentives, lower salaries, lengthy hiring processes, and geographic isolation.

IHS is the only large federal health system to lack formalized partnerships with academic medical centers. This gap hinders the agency's ability to recruit and retain physicians. The Veterans Health Administration, in comparison, has had 75 years of active partnership with teaching hospitals through its Office of Academic Affiliations. The VHA annual <u>budget</u> of \$873.5 million for GME in 2023 will support 75,000 individual trainees and nearly 12,000 GME <u>positions</u>. Academic partnerships provide many benefits, including stability, shared faculty, clinical, and research staff, and a wealth of experience. Virtually all of VA GME programming is sponsored by an academic affiliate and 99% of medical schools are affiliated with VA. This model should be replicated with IHS. This new requested line of funding is needed for the IHS to coordinate existing and burgeoning programs locally, and liaise with partners such as academic medical centers and agencies like VHA, HRSA, and CMS. Given the longstanding precedent across

Indian Country of regional coordination and local self-governance, funding should be made available for GME coordination at multiple levels of governance.

Residency programs are important for recruiting and retaining physicians to underserved areas. Physicians who train in rural environments are much more likely to stay and work there over the long-term. There are only a handful of residency programs at tribal facilities, and there is only one federally supported physician residency program across 24 IHS hospitals (Northern Navajo Family Medicine Residency). Programs with annual discretionary funding under HRSA, including Rural Residency Planning and Development (RRPD) and Teaching Health Center GME (THCGME), are productive initiatives with already notable impacts on tribal health workforce development. However, this funding does not meet the volume of need, and it does not provide the additional costs required for tribal and IHS GME, such as a longer path to sustainable funding, housing, and travel. As an example of costs to start up residency programs, RRPD awards \$750,000 over a three-year implementation period for recruitment, faculty development, and accreditation. Residency programs vary in per-resident annual payment rates due to distinct and complex financing systems; as a parallel example to IHS GME, the HRSA THCGME program caps funding at \$160,000 per resident.

Clinical fellowship programs are another way to recruit and retain physicians (and other cadres of health professionals) across Indian Country. Fellowships provide training, community, and additional support that aides in the retention of staff. A survey of four current fellowship programs working with tribal and IHS sites revealed significant cost variability depending on location and types of integrated professional development programs. Fellowship costs included faculty time, fellow salary and benefits, housing, travel, professional development costs, licensing, malpractice insurance, recruiting efforts, and program administration. Physician fellowships cost up to \$220,000 per year, but range dramatically based on specialty and depth of professional development training. Scaling up fellows within a program significantly reduces per-fellow costs. The HEAL fellowship—a recent partnership between an academic medical center, University of California San Francisco, and Navajo Nation clinical sites—has recruited and retained two dozen primary care physicians in Navajo Nation. This case and related successes demonstrate the promise of funding fellowships at a larger scale.
