The United States Preventive Services Task Force has issued a draft recommendation for the use of PrEP in individuals at increased risk for HIV. As an "A" recommendation, PrEP would be covered under the Affordable Care Act. Additionally, the AAFP continues to advocate for fair pricing of pharmaceuticals and increased access to evidence-based interventions. The AAFP currently has two policies addressing generic drugs and pricing. The policy, "Generic Drugs," supports the production of affordable generic medications and believes such medications should be readily available for family physicians to
