Personal Statement from Dr. Colbert Nelson

I am studying medicine because of the positive impact that medicine has had on my life, and I hope to have that same or more significant impact through medicine on others. To me, medicine growing up was a complete unknown. No one in my family was involved in medicine or health care. I always felt a desire to pursue more and do more, and these pursuits led me to medicine. As a current PGY-2 and future chief resident, I think that my understanding of medicine is constantly improving but will never be complete. That is what keeps me dedicated to the profession. The field is ever-changing, and I strive to provide the best care possible by staying updated on new changes and innovations. While medicine is a rewarding and vast career, there is ample opportunity to be involved in other activities.

I chose family medicine because it best fits my overall interests, personality, and long-term goals. I value the connections you can make as a primary care physician, including interpersonal skills, compassion, work ethic, and commitment to patients and other colleagues. You can also make your practice and career your own and be a leader in your community. Family medicine was and is the only field I could see myself realistically pursuing. It had everything I thought I wanted in my career when I started this journey before medical school.
