We have reached a point in the pandemic at which our country is simultaneously treating patients who are ill from COVID-19 and scrambling to coordinate vaccine efforts to hopefully get us to the other side of this horrible virus. Advocacy

We are one week into the new Biden administration, and several executive actions have been taken to confront the ongoing COVID-19 pandemic. Of note, President Biden signed a number of orders to prioritize the federal government's COVID-19 response, which have included issuing a mask mandate, creating a taskforce within the White House to continue to focus on the pandemic response, rejoining the World Health Organization (WHO), addressing supply chain challenges through use of the Defense Production Act, prioritizing testing/workforce, and improving data collection.

We expect that the administration will take additional executive actions later this week on health care and immigration. President Biden signed some health care orders this afternoon to strengthen Medicaid programs and to open an enrollment period for individuals looking to obtain coverage through the Affordable Care Act (ACA). Before I close, I want to highlight the importance of reminding our patients and communities that now is not the time to let down our guard in the fight against COVID-19. <u>Preventive measures</u> such as social distancing, <u>mask wearing</u> and <u>handwashing</u> are still important precautions we need everyone to take.

We recently crossed the one-year mark since the first confirmed case of COVID-19 in the U.S. In that year, you have demonstrated the positive difference family physicians make in their communities. I am proud to call all of you colleagues!
