



Board of Directors Report D to the 2017 Congress of Delegates

AAFP Non-Dues Revenue

(1) This is an informational Board of Directors report that provides an annual update on the sources of non-dues revenue for the American Academy of Family Physicians (AAFP) and the development of new sources through public and private foundations; federal grants and contracts; and the General Services Administration (GSA).

AAFP Non-Dues Revenue

(2) The AAFP provides a wide range of products and services to fulfill its mission. Currently, the AAFP's annual operational expenditures are approximately \$85 million; however, revenue from dues comprises only \$29 million—or about 34%—of the funds needed to cover AAFP operations. The remaining 66% is funded from non-dues revenue sources. AAFP senior staff members, under the leadership of the AAFP Board of Directors, have made a concerted effort over the past several years to diversify the AAFP's non-dues revenue streams. In addition, they have worked diligently to ensure that the AAFP's current non-dues revenue drivers are maintained or strengthened to continue supporting the AAFP's overall programming.

(3) Historically, the AAFP has received substantial funding from pharmaceutical companies. Current industry trends in funding are similar to last year's trends. Therefore, the AAFP has been strategically diversifying its product offerings and funding sources to better capitalize on pharmaceutical funding and reach a more diverse audience.

(4) FY16-17 non-dues gross revenue from federal sources (including prime grant awards, subcontracts, and other federal contract mechanisms) exceeds \$1.8 million. As a recipient of federal grant dollars, the AAFP is subject to compliance with audit requirements of the federal Office of Management and Budget (OMB) Circular A-133. A detailed schedule of federal awards and any related audit findings are published in the AAFP's audit report, which is submitted to AAFP leadership independent of this Board report.

(5) The AAFP's Grants Management Office (GMO) develops and maintains policies and procedures for grants management; provides training for internal staff (i.e., grants and program staff); provides technical oversight of all grants staff; and serves as a liaison between grantors and program staff on all issues related to grants management. The GMO also helps to assess performance based on resource effectiveness (e.g., time spent seeking grants, relationship building, grants management), success rate, diversity of funding mix, and funding trends.

(6) The AAFP's top 20 non-dues supporters in gross dollars for FY16-17 are listed below. Sources of non-dues funding include journal advertising (print and online); AAFP Family Medicine Experience (FMX) support (i.e., exhibits, general sponsorships, satellite programs, and product theaters); and other grant and contract support (i.e., continuing medical education [CME], sponsorships, non-accredited education programs, and research). Journal advertising support in FY16-17 decreased from FY15-16 by \$2,149,864. FMX sponsorships in FY16-17 decreased from FY15-16 by \$236,625. Federal dollars secured through prime and subcontract grants and contracts total more than \$1.9 million in non-dues funding for FY16-17. The AAFP's GSA contract awarded a total of \$926,393 in federal dollars through the Health Resources and Services Administration (HRSA) for FY16-17 and appears in the list of top 20 sources of non-dues funding.

State of External Support

(7) The last Board report to the Congress of Delegates (COD) noted that the AAFP continues to experience changes in relationships with pharmaceutical and medical device companies. Challenges persist due to an increase in significant late-stage failures in the research pipelines of major pharmaceutical players, the loss of patent exclusivity for blockbuster drugs, fewer new blockbuster drugs, and a shift to generic prescribing due to increased costs for newer medications. New challenges of note this year are the pharmaceutical companies' increased struggle to get new drugs on formularies and large pharmaceutical players working together to bring drugs to market. Both factors have a strong effect on the amount of money being spent on advertising and education. The uncertain political climate has also caused many companies to be somewhat more cautious in their approach to marketing and grant-related spending.

(8) The pharmaceutical/industry environment remains competitive, and opportunities continue to narrow to specific initiatives. Opportunities for funding to support accredited and non-accredited educational programming require targeted versus broad objectives, impact and reach beyond the family physician, and a high level of outcomes. Multi-year, large dollar (>\$300,000) opportunities are no longer "the norm."

(9) Funding from federal sources is dependent on money made available to agencies in the federal budget. The administration has the greatest influence on the federal budget and funding priorities. Emergent public health issues (e.g., Zika, Ebola virus) and needs may also impact availability of federal funds. The GMO follows the federal budget and appropriations closely. While we do not expect a significant impact on our traditional federal funding sources, we are proactively expanding relationships with agencies that could realize an increase in funding.

(10) The foundation funding environment remains stable. Opportunities for financial support from public and private foundations are generally limited to each foundation's specific mission, priorities, and areas of interest/focus. The reality of this funding stream is that opportunities are limited in frequency (i.e., how often opportunities are available) and longevity (i.e., funding is for a limited time frame). Timing for submissions to foundations is unpredictable; therefore, funding opportunities require constant monitoring. Many foundations do not accept unsolicited applications/proposals, so having a relationship with these foundations is critical to the AAFP's success. In addition, most foundations allow for limited or no recovery of indirect costs. The Strategic Partnerships Division (SPD) and its internal partners must carefully consider the

1 financial impact of operating a project—especially one that inflicts a heavy administrative burden—within
2 these limitations.

3
4 (11) Most pharmaceutical and health care companies are implementing a higher level of scrutiny and
5 review of proposed programs to ensure their expenditure results in a high return on investment. As
6 competition increases for funding, it will be crucial to strengthen our initial proposals and our outcomes
7 reporting. Limited requests for proposals (RFPs) and restricted opportunities for grant submissions continue
8 to be the norm. Supporters are shying away from single-support activities and are encouraging multi-support
9 programs/grants instead. This increases the complexity of securing support for a single activity.

10
11 (12) Industry's funding environment affects support for CME produced by the AAFP and its chapters. The
12 Continuing Medical Education Division and the SPD continue to work together closely to identify programs
13 that will benefit chapters and the AAFP. Although industry support for accredited CME is unlikely to
14 disappear entirely, greater restrictions have resulted from cultural, regulatory, and economic changes.

15
16 (13) Funding secured for sponsored projects (both CME and non-CME) in FY16-17 decreased by \$2.8
17 million from FY15-16. Support for CME programs in FY16-17 decreased by more than \$800,000 from the
18 previous year. Funding secured for non-accredited projects, including dollars secured from foundation and
19 federal sources, decreased by \$1.9 million from FY15-16. The SPD continues to secure equipment for in-
20 kind support of FMX and national procedural skills CME programs.

21 22 23 **AAFP Family Medicine Experience and National Conference**

24
25 (14) The AAFP Family Medicine Experience continues to be a major source of non-dues revenue, with a
26 consistent number of companies exhibiting. While larger exhibit booths are beginning to shrink in size due
27 to exhibitors' budget constraints, the number of smaller company exhibitors has increased, which has
28 resulted in a maintained level of square footage for the FMX Expo Hall. In FY16-17, total non-dues revenue
29 from FMX sales decreased by \$236,625 from FY15-16. Revenue from FMX exhibit sales, sponsorships, and
30 satellite CME events decreased by \$351,488 in FY16-17. Revenue from registration and other meeting-
31 related income increased by \$331,507 from the previous year. Grant support (both CME and non-CME) for
32 FMX increased by \$114,863 from FY15-16.

33
34 (15) Exhibit and sponsorship revenue from the National Conference of Family Medicine Residents and
35 Medical Students increased in FY16-17 by \$32,050 from the previous year.

36 37 38 **AAFP Journal Advertising Revenue**

39
40 (16) Journal advertising produced \$11,987,734 in revenue in FY16-17, 68% of which was for advertising
41 in *American Family Physician (AFP)*. Pharmaceutical advertising—particularly print advertising—is
42 overwhelmingly the largest source of journal revenue. It is predominantly impacted by external forces
43 beyond the control of any medical journal, namely, pharmaceutical product development activity and
44 pharmaceutical economic factors that impact spending decisions. Because this phenomenon impacts all
45 medical journals, *AFP's* advertising market share remains strong in both up years and down years, and *AFP*
46 is still the top advertising buy in primary care.

47
48 (17) Non-pharmaceutical products now represent 45% of all AAFP journal advertisers. However, due to
49 their smaller budgets and single-page ads, they represent only 14% of total advertising revenue.

50
51 (18) Online (i.e., website) advertising is approximately 20% of the journals' total advertising revenue, with
52 \$2.4 million in gross revenue generated by the journals in FY16-17.

1 (19) Print classified (i.e., recruitment) advertising also contributes to the AAFP's non-dues revenue, with
2 \$1.4 million in gross revenue generated by the journals in FY16-17.

3
4 (20) *Family Practice Management (FPM)* generated approximately \$322,988 in total advertising revenue
5 in FY16-17; approximately 81% of this revenue is from online advertising. *FPM* advertising is sold primarily
6 in conjunction with *AFP* advertising through package buys, which help both *AFP* and *FPM*.

13 14 15 **Educational Programs**

16
17 (21) Support for AAFP CME programming in FY16-17 decreased from FY15-16 by \$832,944. Support for
18 non-accredited education (e.g., office-based tools, patient education, and research) decreased by
19 \$1,994,545 from the previous year.

20
21 (22) The challenges in securing support for CME can be attributed, in part, to ongoing regulatory
22 pressures. In addition, industry grant offices continue to dedicate less money to exclusively support large,
23 longitudinal CME programs that offer a higher level of learning, are comprehensive, have outcomes
24 analyses, and can accurately measure impact on patient and population health. RFPs that include specific
25 requirements to support a structured selection process are common, and many industry grant offices have
26 implemented limited grant-funding cycles. These cycles give the AAFP only one or two opportunities per
27 year to submit proposals.

28
29 (23) Industry views the AAFP as a leader in producing CME programs. Therefore, the AAFP still captures
30 a portion of the market and is a key organization that industry will continue to support.

31 32 **Transparency**

33
34 (24) In April 2011, the AAFP adopted the Council of Medical Specialty Societies (CMSS) *Code for*
35 *Interactions with Companies*. The AAFP has endorsed these guidelines to reinforce core principles that help
36 us maintain actual and perceived independence, as well as to ensure that interactions with companies
37 benefit patients and members and improve quality of care. Appendix A is included as part of this report and
38 posted on aafp.org in support of the CMSS code and in the interest of transparency to AAFP members and
39 the public.

40 41 **Future**

42
43 (25) Non-dues sources of funding make up most of the AAFP's revenue and, therefore, are critical to its
44 ongoing success. As a not-for-profit, health-related membership organization, the AAFP limits its sources of
45 non-dues revenue to those that are ethical, aligned with the AAFP's mission, and consistent with the values
46 and expectations of AAFP members and their patients. To that end, the AAFP is committed to creating a
47 diverse portfolio of non-dues revenue opportunities that deliver quality products and services to save AAFP
48 members time and provide up-to-date, evidence-based information for members and the patients they serve.

49
50 (26) Industry support continues to decline due to the impact of numerous regulations and the lack of new
51 blockbuster primary care drugs. SPD staff members have been—and will continue to be—focused on
52 diversifying sources of support in addition to pharmaceutical and medical device companies. Building and

1 maintaining relationships is a critical component of the AAFP's success. The SPD, through its Grants
2 Management Office, has intensified efforts to cultivate relationships with foundations, government agencies,
3 and other non-traditional sources and to identify funding opportunities from these sources. Cultivating
4 relationships in the industry sector has proven the need for greater focus on communicating relevance and
5 return on investment so that the AAFP can be competitive despite narrowed budgets and the structured
6 decision making implemented by industry to more closely mirror behaviors of federal and foundation
7 sources.

8
9 (27) AAFP leadership will continue to develop a three- to five-year plan to strategically identify funding
10 sources in a cost-efficient and targeted manner in order to optimize and sustain support for important
11 member programming and AAFP strategic priorities.

12
13 (28) The AAFP believes it is important for members and the public to be informed regarding sources of
14 non-dues revenue. Toward that end, partnerships and collaborations are publicized through a variety of
15 communications, such as news stories, acknowledgments, and other Board reports. These communication
16 mechanisms are more effective and more timely, and provide greater context than a one-time-per-year
17 Board report that simply lists names and amounts. Therefore, the Board of Directors is recommending that
18 this annual Board report be discontinued after 2017. The AAFP Board remains committed to accepting
19 outside funding only in accordance with the highest ethical and organizational standards, with full disclosure
20 of sources in all appropriate circumstances.
