## RECENT AAFP GERIATRIC CARE ACTIVITIES

PROGRAMS AND PROJECTS	DESCRIPTION
AAFP Foundation, <i>2016 Senior Immunization Grant Awards</i> (Funded by Pfizer Inc.)	<p>Grants provided by Pfizer Inc. allowed resident physicians from seven Family Medicine Residency Programs (FMRP) to learn quality improvement project design, implementation and analysis by focusing on increasing the immunization rates of medically underserved patients age 65 and older during the 2016-2017 influenza season (September 2016 through March 2017). Influenza immunization rates for seniors, when averaged across all six FMRPS, improved by an average of 17.9%. Continuing Medical Education (CME) (ongoing live and enduring) (Funders included Allergan and Novartis along with AAFP-produced activities)	<p>Selected courses presented at the 2017 Family Medicine Experience (FMX) have included: Heart Failure: For the Faint of Heart; Dementia and Alzheimer’s Disease: Providing Quality Care to Patients with Dementia (problem-based learning session which utilized simulated case-style discussion); and Adult and Elderly Hypertension.</p> <p>Selected courses from the Geriatric Medicine Live National meeting have included: Geriatric Polypharmacy &amp; High Risk Medication Use; Alzheimer’s Dementia: Diagnosis &amp; Management; Immunizations Update; and Anticoagulation Update.</p> <p>Selected courses from Geriatric METRIC Module have included: Behavioral Symptoms of Dementia; Eye Conditions in Older Adults; and Care of Patients at the End of Life.</p>
National Research Network <i>Cognitive Care Kit</i> (Funded by Lilly USA, LLC)	<p>The Cognitive Impairment in Older Adults Toolkit Project (2015-2017) provides tools and resources to primary care providers, care team members, patients and caregivers to encourage practice culture that promotes the needs of aging populations related to cognitive health. It is also exhibited at national and state meetings and conferences. <p>HealthLandscape Medicare Data Portal, <i>Evaluating Geographic Variation and Growth in Health Care Spending</i></p>	<p>Recently, the Institute of Medicine (IOM) contacted the Centers for Medicare and Medicaid Services (CMS), requesting new datasets and analyses that would benefit the evaluation of geographic variation and growth in health care spending and the volume and intensity of health care services utilization. In response to the IOM request, CMS created four datasets using the new Geographic Variation in Medicare Spending and Utilization (GV) database, which uses Medicare claims data to calculate utilization measures and total, standardized, and risk-adjusted spending. Using these data sets, HealthLandscape created a portal that incorporates Chronic Condition indicators, including Diabetes, Heart Failure, and Chronic Obstructive Pulmonary Disease, and data from the Dartmouth Atlas.</p> <p><a href="http://www.healthlandscape.org/MedicareDataPortal">www.healthlandscape.org/MedicareDataPortal</a></p>
<p>HealthLandscape Nursing Home Explorer</p>	<p>Nursing Home Compare allows consumers to compare information about nursing homes. <p>Health of the Public (HOPS) Immunization Information Systems (IIS) web-based map (funded by AAFP Foundation through a grant from Sanofi Pasteur)—January 2017</p>	<p>The web-based Immunization Information Systems (IIS) map displays the laws and regulations required for immunization registries in all 50 states, Washington, D.C., Puerto Rico, the Virgin Islands, and Guam. <p>Health of the Public (HOPS) Adult Immunization Office Champions Project (funded by the CDC)—September 2015 to September 2019</p>	<p>The project is funded by the CDC to provide tools and strategies to develop a culture that promotes immunizations in the practice setting. An online version of this quality improvement model will be developed and made available to the entire AAFP membership.</p>
<p>National Research Network Addressing Barriers to Adult Immunizations in a Medical Neighborhood (funded by Merck Sharp &amp; Dohme Corp.)—January 2015 to February 2017</p>	<p>The project is a prospective cohort study of the effectiveness of a multi-component intervention to increase immunization rates among adults. The focus is to study the effective, synergistic effects of a multi-component approach and transfer of training using the Practical, Robust Implementation and Sustainability Model (PRISM) and Reach Effectiveness-Adoption Implementation Maintenance (RE-AIM) frameworks.</p>
<p>Health of the Public (HOPS) <i>Familydoctor.org</i>, redesigned Dec. 2016 – present</p>	<p>FamilyDoctor.org is the AAFP’s patient facing website that allows the AAFP to share health information for a variety of diseases, conditions and other health issues with members of the public. This information is based on the best available scientific evidence or best clinical practice, and is aligned with the AAFP’s policies. <p>HealthLandscape Primary Care Workforce Mapper</p>	<p>The Primary Care Health Workforce Mapper explores the gaps between the geographic location of primary care providers and the healthcare needs of the population. The tool allows users to map primary care physician and non-physician practice locations in the United States, along with other healthcare facilities including hospitals, community health centers, and Rural Health Clinics, as well as Health Professional Shortage Areas and Medically Underserved Area/Population designations.</p> <p>The tool linked here includes physicians who identify themselves as “geriatric medicine” providers, but we can also include a variety of other practitioners including geriatric psychiatry, physical therapists specializing in geriatric care, physical medicine and rehabilitation specialists, urologists, gerontologists, and many others.
