The AAFP [shares your commitment](#) to improving health care coverage, advancing health equity, and facilitating the transition to value-based care. Investing in primary care is an essential strategy to achieving these shared goals: evidence confirms that primary care mitigates health disparities and improves patients' access to and utilization of low-cost, high-value care that ultimately results in better patient outcomes and population health.^{1,2,3,4} In order to ensure every American can get the comprehensive primary care they need, we look forward to partnering with you to strengthen Medicare, Medicaid, and marketplace coverage, build a robust primary care workforce, expand primary care alternative payment models (APMs), and reduce physicians' administrative burdens.

[Improve Health Care Coverage, Affordability, and Access](#)

- Protect and expand Medicaid coverage eligibility and ensure beneficiaries' access to primary care by raising Medicaid payment rates to equal at least Medicare rates.
- Strengthen marketplace coverage reversing harmful regulations that undermine affordability, essential benefits, and marketplace stability.
- Invest in high-value primary care by addressing Medicare payment imbalances.
- Continue to restore and codify non-discrimination protections for all individuals, including LGBTQ+ patients, those with limited English proficiency, individuals with disabilities, and those seeking access to comprehensive reproductive health care.
- Permanently cover high-value telehealth services, including audio-only visits, that are provided as part of a patient's medical home.

[Expand and Diversify APMs that Center Primary Care](#)

- Develop, with ongoing input from physician stakeholders, [transparent, stable APMs](#) to recruit and retain physician practices into value-based care.
- Immediately make [technical improvements](#) to existing models to ensure long-term success.

Reduce Administrative Requirements So Physicians Can Focus on Patient Care


