I'm a wife, mom, professor and passionate family doc. I've been an active member of AAFP since 1993 and have served in a variety of membership and leadership roles in my state academy since that time. I work at the residency program of the University of Oklahoma Department of Family and Preventive Medicine where I serve as

Medical Director of our clinic, which cares for more than 50,000 mostly Medicaid and Medicare patients per year. We have the highest acuity patient population in the state, and were recently awarded track 2 CPC+ status in addition to our status as a tier 3 PCMH. Prior to joining the university, I served a completely different population as a private practice doc for 7 years, and understand the challenges facing our colleagues in the community.

Among my greatest passions are mentorship and advocacy. In my role as faculty, I serve as advisor to our FMIG, helping students discover Family Medicine and develop into the best possible residency candidates. As advisor to our Families and Medicine interest group, I assist students in balancing work life with “real” life. As co-moderator of the Physician Moms in Family Medicine Facebook community, I facilitate discussions among more than 2,000 “sister docs,” encouraging them in overcoming challenges in work/life balance or negotiating their career paths, and connecting them to opportunities across the country. As an active member of the #FMRevolution, I help advocate for those priorities that all family docs share. As a member of NCSC/NCCL since 2010, I have helped our junior delegates develop resolutions which have become policy. Most notably, I was an editor and co-author of a recent resolution on differential policing as a social determinant of health, which found support at both the national congress of delegates and at the AMA.

I have attended NCSC/NCCL since 2010. I have served as Women’s Delegate from Oklahoma every year except the 2017 cycle, when I am expecting to serve as GLBT Ally unless our delegation changes. I have served on Reference Committees and as Co-Convener for the Women’s Delegation. During my year as Co-convener, my fellow Co-convener and I worked to enhance the cross-delegation collaboration during resolution writing sessions, which helped develop into the current practice of the delegations writing resolutions together in the cafe area. This has been by far my favorite change of the past 7 years, being given the opportunity to mingle with delegates of all constituencies, educate new delegates in researching, writing, editing and submitting resolutions, and getting to know people outside my delegation in the process!

I serve as one of three elected members of the board of directors of OU Physicians, the largest physician group in Oklahoma, representing more than 800 providers (including around 680 physicians of all specialties). As medical director of the clinical practice, I oversee the care provided by 36 resident physicians, 18 faculty physicians and 3 non-physician providers to the population previously described. I have certification in LEAN/SIX Sigma, and in this capacity serve as an elected member of the task force currently working to integrate our clinical practice with another large practice group.

I speak in both educational and advocacy arenas: I am the online face of OU Medicine, and as such engage in media interviews more than 20 times per year. I’m also one of the physician liaisons for our practice, and as such develop educational videos for our intranet regarding EHR and other topics. As developer and director of our nationally-recognized chronic pain management curriculum, I’ve been invited to speak with the White House Director of National Drug Control Policy and with the U.S. Surgeon General regarding physician educators’ response to the opioid addiction crisis.

If elected, I would use my time as convener to develop new talent to replace me. I am in love with NCCL and all it represents, and hope I could help us weather a tough current climate to maintain excitement for the important advocacy work that we do.

## Personal Statement

My engagement with the AAFP at large began as an incoming chief resident. My program sent my co-chief and me to the AAFP's chief resident leadership development conference ... I went with no idea of what to expect. The second session of the meeting was held in conjunction with what was then called the Annual Scientific Assembly in Denver, CO. I was inspired and proud to count myself as a member among such a dynamic group. I wanted to be at the meeting every year, but I had no idea that there was more.

My involvement in the NCSC and now NCCL was serendipitous. In the summer of 2012, I opened my email to find a bulletin from my California AFP chapter detailing the success of the 2012 NCSC conference, and the election of one of my medical school classmates. Organizing peers and running meetings is solidly in my skill set.

I want to serve as convener of NCCL because I know I can do a great job. And because I feel that it is time for me to make the next leadership leap. I am reliable, organized and passionate. I am inclusive and I bring people together. As a mother of teenagers, I always remember to have fun while getting the job done. I am inclusive and work to bring people together. I represent the best of what NCCL stands for, and in one person, embody three of the five constituencies, but also share roots, values and understanding with the other two that don't directly describe me.
