

## COVID-19: Testing Resources, Employment Assistance and Rural Health

We have entered another week of fighting this pandemic. As cities and states reopen and ease restrictions, we face many of the same challenges, along with some new ones. At the AAFP, we continue to advocate and provide resources to help you support your patients and community.

### Testing Resources

Testing continues to be a hot topic — especially as communities begin to reopen. From access to tests to special equipment that may be needed, we know you may have a lot of questions. This week, the AAFP introduced new resources (with one more on the way) that we hope you'll find helpful.

### Financial Relief and Practice Management



- **EIDLs:** Last week, the Small Business Administration (SBA) announced that all new applications for an Economic Injury Disaster Loan (EIDL) must be to provide relief specifically for U.S. agricultural businesses. If you submitted an EIDL application before May 4, your application will continue to be reviewed on a first-come, first-served basis. However, family physicians are unfortunately no longer able to apply for this funding. The AAFP continues to advocate for the federal government to do more to support primary care. - Audio-only E/M visit payment: I want to share some good news on the payment front that is a direct result of the AAFP's advocacy efforts. Recently, the Centers for Medicare & Medicaid Services (CMS) announced an increase in the payment rate for audio-only telephone evaluation and management (E/M) visits. This is retroactive to March 1, 2020. The new rates align with in-person E/M office visit rates, which now range from \$46-\$110. - **Employed physician contract changes:** As the U.S. sees a record number of health care jobs being lost, employed physicians may be faced with changes to their employment contracts, reduced hours, furloughs or termination. To help employed physicians navigate changes to their employment situation, the AAFP has developed an [employment assistance guide](#).

I will close with a couple of quick reminders:

- **Make your voice heard:** As the federal government considers additional legislation, it is critical that Congress hears from you about the importance of family medicine and the need for support. With our [Speak Out tool](#), you can easily contact your members of Congress to let them know the impact COVID-19 is having on your practice and that much more must be done to support family physicians.
